Taking place online from 17 to 25 November 2025, this pan-European event invites developers, startups, researchers, and SMEs to build innovative digital solutions that champion privacy, sustainability, interoperability, and trust in the next-generation internet.

Organised under the umbrella of the NGI TrustChain project, the hackathon aims to amplify the impact of TRUSTCHAIN-funded technologies by encouraging new and existing teams to co-create tools that tackle real-world challenges through decentralized, human-centric innovation.

HACKATHON OVERVIEW

The TRUSTCHAIN Hackathon brings together forward-thinking minds to develop **interoperable, scalable, and ethical** digital applications. Participants will work with the **existing TRUSTCHAIN technology** ecosystem, reimagining what a sustainable and trustworthy internet can look like.
